To improve their efficiency, one of the largest school districts in Missouri needed to replace cumbersome and error-prone manual data entry processes. Data from one system was pulled using a manual report, reviewed for new records or changes, then revised in another system. OTSI built an automated process using Azure Data Factory to pull the data from the first system, normalize and format the data, then ingest the data into the accounting system. The data was also used to provide updates to yet another outside system. These integrations save a lot of time and ensures accurate and timely information.
